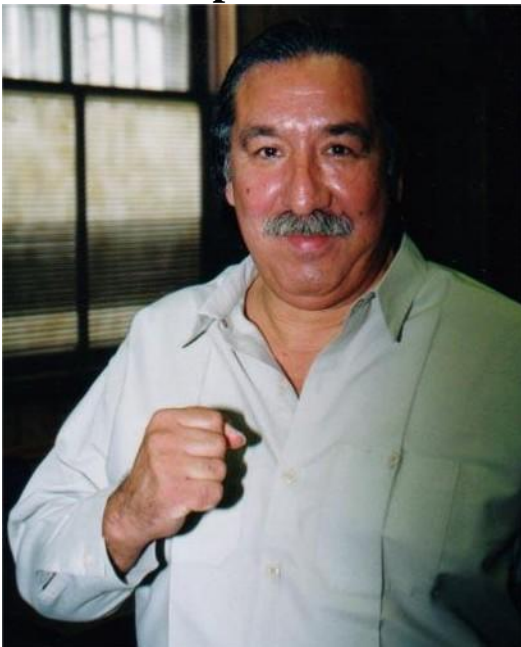

Dear NPPA supporters:

In the line of duty: On November 19th, FBI Special Agent Samuel Hicks participated in a multi-agency narcotics investigation and entered a residence in Glenshaw, Pennsylvania to arrest one of the subjects. The subject's wife shot and killed SA Hicks. The NPPA offers its condolences to SA Hick's wife and son, Brooke and Noah, his parents, relatives and friends. He will be in our prayers.

In order to place the entire Peltier matter in its proper perspective,



one needs to remember this face—and the clenched fist. We can only assume that at around noon on June 26, 1975 Jack Coler was probably unconscious from his devastating arm wound. Although wounded three times, Ron Williams, we know, was conscious and raised a hand to deflect the muzzle pointed at him.

This is probably the last face Ron saw except that instead of a clenched and defiant fist, it held an AR-15. The weapon was fired, destroying Ron's face, ending his life and then turned on the dying Jack Coler. Certainly, only three people know precisely what occurred in those final moments; Dino Butler, the coward Robert Robideau and Peltier. Please remember this as we move toward Peltier's first public parole hearing.

Peltier on the Move: Peltier, according to his sister, Betty Ann Solano, is in the process of being relocated from Lewisburg. She claimed that he has been a "model prisoner" and encourages Peltier supporters to write letters to get him transferred "...to the Turtle Mountain Reservation's custody as soon as possible." Perhaps Solano has forgotten about the armed escape from Lompoc Penitentiary and the other things he mentions in his own book, let alone running an illegal business from behind prison walls <http://www.noparolepeltier.com/debate.html#fraud>. Her memory seems to have also erased his more than questionable "charitable" activities. And besides, he's in *U.S. federal* custody for the duration. She also said that this transfer "...seems to be a strategy by the federal government to disrupt his defense committee."

Certainly, this makes sense to Solano...that the entire Bureau of Prisons is reassessing its prison level priorities and designations just so it can inconvenience Peltier. Hardly. However, what's odd about Solano's announcement is that it didn't appear on the LPDOC's website (or the freepeltiernow.org, or KOLA for that matter) but in a Communist inspired website; workers.org. Perhaps it's trite and a bit passé to refer to it as a "*commie*" site, but take a look at their homepage banner message and its call to arms; "workers & oppressed peoples of the world unite" (along with a big red star in the title).

"Dear President Obama" On November 5, 2008 Peltier released a statement regarding the recent election, his thoughts on the

possibility of a grant of clemency from the new president, efforts to secure parole and further reorganization within the Peltier network. Peltier covers a lot of ground, too much to respond within a newsletter. The NPPA response will be posted to the website soon in Editorial Essay #45 in the Debate Continues section. It will also include Solano's post of November 4th where she demonstrates a fundamental ignorance of the facts surrounding her brother's case.

“They died because they were stupid.” This is a quote from a November 25th email from Peltier supporter, Pamela Kaechele. The NPPA receives many emails, some intelligent, coherent and sincere, others not. Between other attempted clarifications Kaechele, like so many other Peltier supporters, just can't wrap themselves around the facts, i.e. claiming the agents had no right to be on the Reservation, that they were searching for shoplifters, and that Joe Stuntz was perhaps murdered by either Coler or Williams, etc. Actually, felony kidnapping and assault is not shoplifting, the FBI does have federal jurisdiction on Indian Reservations and Stuntz was killed as he engaged and fired at responding law-enforcement officials well after Agents Coler and Williams were wounded and murdered at Jumping Bull. Let this serve as a typical and shining example of the type of people who are unwilling, or unable, to understand the facts surrounding Peltier but instead pander to the folklore that only supports the Peltier Myth. These are the kinds of people Peltier needs and wants in his corner.
