Dear NPPA supporters:

On January 12th Peltier was transferred to another federal prison in Pennsylvania. Peltier and the Leonard Peltier Defense Offense Committee (LPDOC) tried to claim it was punitive and made a feeble campaign to have him transferred to the custody of the Turtle Mountain Reservation in North Dakota, where, no doubt, they hoped he would be promptly paroled. An unlikely dream to be sure. Instead, the Bureau of Prisons reclassified the Lewisburg facility and transferred Peltier to another Pennsylvania prison. His new address is; Leonard Peltier, Inmate #89637-132, UPS Cannan, U.S. Penitentiary, P.O. Box 300, Waymart, PA 18472; in case anyone is interested in corresponding with him.

In a statement from Peltier “Dictated by phone January 12, 2009” he rambled about world events and that he shared something with another “political prisoner,” Jesus Christ. Peltier compares himself to many great Native American Chiefs and warriors and goes on to define what he views as cold-blooded murder as having “no sense of right and wrong or something of that nature when you take a life.” And he is correct there...just ask, if we could, Jack Coler and Ron Williams. Peltier professes innocence in the face of three decades of undeniable proof of guilt that has been more than reinforced by his two aider and abettors, Dino Butler and the disgusting Bob Robideau. Peltier also brings up again his ridiculous excuse (a government assassination plot against him) to justify his armed escape from Lompoc Penitentiary in 1979. And to quote Peltier directly, he said “They had a trial and tacked seven more years onto my two consecutive

life sentences" (Prison Writings, p.167). So, since he brought it up, we'll remind him, and all Peltier supporters (and everyone else), that besides his back-to-back life sentences he still owes seven (7) additional years for that criminal act.

According to the LPDOC Peltier may have his first public parole hearing in February. We anxiously await the date to will ensure that everyone interested knows and understands the depth of Peltier's remorseless guilt; guilt that he insults all Native Americans with by trying to hide behind a veil of Indian nobility.

The LPDOC and Peltier launched yet another attack, this one on U.S. Senator Byron Dorgan (D-ND), Chairman, Senate Committee on Indian Affairs because he had the temerity to say that Peltier's trial (assuming also his conviction and sentence), was "fair and just." Peltier claimed that Senator Dorgan was ignorant of true Indian history, had no knowledge of his case, and then referred to Senator Dorgan as a "lackey" to the Government's sense of justice that didn't include him or Native Americans.

We're certain that Senator Dorgan has availed himself of Peltier's conviction and history and has made his own independent judgment concerning Peltier's rightful incarceration.

NPPA Editorial Essay #46 (to be posted on the website and distributed widely in a couple of weeks) will certainly bring attention to all the elements surrounding Peltier's legal history, unvarnished guilt and hallucinations of a pardon.
